# D7 Visa Overview



The D7 visa is geared towards non-EU citizens looking to move to Portugal who earn **monthly passive income** of at least **€920** – the current Portuguese minimum wage. Higher thresholds apply if you plan to bring dependents. Sources of passive income include rental, dividends, interest, royalties, pensions, social security, and so on.

Though often associated with retirement, the D7 visa is in fact open to applicants of any age, provided you can demonstrate qualifying passive income. If your application is successful, you'll be granted a four-month visa, which you must convert into a two-year residency permit upon arrival in Portugal

The D7 is ideal for those who want to live in Portugal without needing to actively work. That said, after converting your visa into a residency permit, you can work, if you choose to do so.

## Key Benefits

### ✓ Lowest Financial Threshold

The D7 has the lowest income requirement – €920 p/month. This applies not only to Portuguese residency visas but also in comparison to similar EU routes – for instance, Spain's Non-Lucrative Visa requires requires €2,400 p/month.

### ✓ Family Inclusion & Reunification

Bring eligible family members with you, including your spouse or long-term partner, dependent children, and dependent parents (subject to certain criteria).

### ✓ Schengen Area Travel

Enjoy visa-free travel across the Schengen Zone.

### ✓ Path to Citizenship or Permanent Residency

After 5-years of legal residence.

## Main Requirements (1)

### Financial

Proof of €920 per month in passive income, plus an additional 50% (€460) for each adult dependent and 30% (€276) for each dependent child.

### NIF (Portuguese Tax Number)

### Portuguese Bank Account

### Accommodation

You must secure either a 12-month rental contract or a property purchase agreement.

### Travel Insurance

You must have a valid insurance policy that meets the minimum required coverage criteria.

## Main Requirements (2)

 **Criminal Background Check**

 **Marriage Certificate**

If applying with your spouse.

 **Birth Certificates**

If applying with children.

 **Additional Documentation and Formalities**

Other requirements also apply.

Supporting documents will vary based on your income type, personal circumstances, and the country where you're applying. Documents might also need to be translated, notarised, and apostilled.



# D7 VISA

## The Process

### 1. Gather Your Documents:

Compile all necessary documents into an application folder.

### 2. Book Your Visa Appointment:

Schedule an appointment at the nearest Portuguese consulate/embassy or VFS Global office in your country of residence.

### 3. Attend the Appointment:

This is where you submit your D7 application and supporting documents.

### 4. Wait for Approval:

Visa processing usually takes 4–12 weeks, depending on where you apply.

### 5. Collect Your Visa:

If approved, your passport will be stamped with a four-month visa allowing two entries into Portugal.

### 6. Relocate to Portugal:

Move to Portugal and wait for your appointment with AIMA.

### 7. Attend Your AIMA Appointment in Portugal:

At this stage, your four-month visa will be converted into a two-year residency permit.

### 8. Renew Your Residency Permit:

If you wish to remain in Portugal, you can renew your residency for an additional three years.

## Timeline – How Long Does It Take?

### **Document Preparation:**


This typically takes around 6–12 weeks.

### **Visa Processing:**

Processing times vary depending where you apply from, but generally takes around 4–12 weeks.

### **Property Requirement:**

# D8 Visa Overview



This visa is specifically designed for **remote workers, freelancers, and digital nomads** who earn at least **€3,680 per month**, which is four times the current Portuguese minimum wage. While the Digital Nomad Visa is commonly referred to as the D8 Visa, the numbering can vary between countries, so it's best not to rely too heavily on it when researching.

This guide focuses on the **long-term Digital Nomad Visa**, which offers a legal pathway to residency. There is also a short-term version: a one-year visa that does not convert into a residency permit and is intended for those planning to live and work remotely in Portugal on a temporary basis.

The D8 is ideal for those who **already have remote income** and wish to live and work remotely from Portugal.

# D8 VISA

## Main Requirements

### Financial

€3,680 p/month from a remote job, self-employment, or freelance work. The specific documentation required will depend on the nature of your professional activity. If you're applying with dependents, you must show additional income: 50% of the Portuguese minimum wage (€460) for each adult dependent, and 30% (€276) for each child.

### Other Core Requirements

The same main requirements as the D7 visa (above) also apply: NIF, PT bank account, proof of accommodation, travel insurance, criminal record certificate, and so on.

### Pitfalls to Be Aware Of

# D8 VISA

## The Process

The application process for the long-term D8 Digital Nomad Visa follows the same steps as the D7 Visa outlined on page 9, above.

## Timeline

The document preparation and application processing timeline is the same as for the D7 Visa outlined above, typically taking 12–24 weeks from start to finish. There is also no apparent difference in the turnaround times for the D8 when compared with the D7.



# Golden Visa

## Overview



Portugal's Golden Visa is a residency-by-investment program designed for non-EU nationals seeking a strategic foothold in Europe, without the need to relocate full-time. It offers a flexible & low-commitment pathway to Portuguese residency, and eventually citizenship. Applicants must **invest €500,000** in an eligible Portuguese fund (maintained for a minimum of 6 years) or **donate €250,000** to an approved artistic or cultural heritage project.

The program is especially attractive to investors, entrepreneurs, and high-net-worth individuals who want to establish a legal base in Portugal for personal, financial, or lifestyle reasons, while retaining the freedom to live elsewhere. Unlike the other visas, it does not require extended physical presence in Portugal each year. **Just 14 days of physical presence within each two-year period** is sufficient to maintain residency status and stay on the path to citizenship or permanent residency.

## Key Benefits

Just 14 days of physical presence in Portugal within each two-year period to maintain residency, compared to the 16 months out of 24 required by the D7 and D8.

Provided you spend fewer than 183 days per year in Portugal, you generally won't be considered a Portuguese tax resident – meaning you can retain tax residency in another country if it's more advantageous. However, for those looking to move, Portugal's new Incentive for Scientific Research and Innovation (IFICI) – the successor to the NHR – may offer highly attractive tax benefits for eligible individuals

# Golden VISA

## Qualifying Investment Options

In recent years, the program has entered a new chapter. Following legislative changes in 2023, the once-dominant real estate option – previously responsible for almost all Golden Visa applications – was removed. Since then, investor interest has shifted toward alternative routes such as regulated private equity and venture capital funds and business creation.

### **Options (considered in detail below):**

1. Investment in a Portuguese Private Equity Fund
2. Donation to Arts or Cultural Heritage
3. Job Creation
4. Incorporating or Investing in a Portuguese Business



# Golden VISA

## Qualifying Investment Options (1)

### 1. Investment in a Portuguese Private Equity Fund

In 2025, the most popular route to securing a Golden Visa is through investment in a Portuguese private equity fund. These professionally managed funds pool investor capital and typically focus on high-growth sectors such as technology, healthcare, hospitality, and innovation-driven start-ups.

To qualify, you must invest a minimum of €500,000 into one or more eligible funds. Each fund must have a minimum maturity of 5 years and must allocate at least 60% of its assets to companies headquartered in Portugal. Notably, funds with exposure to real estate are excluded from eligibility. The investment must be maintained for at least the duration of the Golden Visa.

All qualifying funds are regulated by Portugal's financial authority, ensuring oversight, transparency, and investor protection. Some financial institutions may offer structured financing options to reduce the initial capital outlay, though these come with additional factors to consider (see below).



# Golden VISA

## Qualifying Investment Options (2)

### 2. Donation to Arts or Cultural Heritage

Among the lower-cost Golden Visa pathways is a contribution of at least €250,000 to approved cultural, artistic, or heritage preservation initiatives in Portugal. To qualify, the project must be officially recognised and authorised by GEPAC, the government body overseeing cultural funding. While this route offers a more affordable entry point, it is less commonly chosen, as the donation is non-refundable and considered a sunk cost

### 3. Job Creation

Applicants can also qualify by generating a minimum of ten full-time jobs within Portugal. No minimum investment amount is specified for this option.

### 4. Incorporating or Investing in a Portuguese Business

Another qualifying route involves transferring at least €500,000 in capital to either establish a new company or increase the share capital of an existing business registered in Portugal. This investment must be accompanied by the creation of at least five permanent jobs, maintained for a minimum period of three years.

## The Process (1)

### 1. Engage a Trusted Service Provider

The process typically starts by working with a reputable company offering comprehensive services – from investment advice to legal compliance and visa application handling. While we don't process Golden Visa applications directly, we have partnered with a seasoned expert who has over 25 years of experience in international wealth management and investment migration.

### 2. Prepare Documentation

Collect and legalise all necessary documents as directed by your service provider. Requirements vary based on individual circumstances. A NIF (Portuguese tax number) and a Portuguese bank account are also required

### 3. Select and Fund Your Investment

Choose your investment route – most often a private equity fund – and transfer the required amount from your Portuguese bank account. Obtain written confirmation of the investment from both the bank and the fund manager or beneficiary institution.



# Golden VISA

## The Process (2)

### 4. Submit Your Application

Your service provider will submit your Golden Visa application to AIMA. Application fees are paid at this stage.

### 5. Approval and Biometrics Appointment

The longest stage in the Golden Visa process is the wait for AIMA to approve your application and invite you to a biometrics appointment. Current wait times typically range from 12 to 24 months after submission. Once approved, you'll be required to attend a biometrics appointment in Portugal, where your fingerprints, photo, and identification will be recorded.

**⚠ NOTE:** The five-year countdown toward citizenship begins from the date your application is submitted, not from the date of approval.





# Golden VISA

## The Process (3)

### 6. Receive Your Residency Card

Your first residency card will be issued after your biometrics appointment.

### 7. Maintain Eligibility and Renew

To keep your Golden Visa, you must spend at least 14 days in Portugal every two years and maintain your qualifying investment.

### 8. Apply for Citizenship or Permanent Residency

After five years of legal residency, you may apply for Portuguese citizenship or permanent residency.

⚠ As mentioned above, the time required to qualify for Citizenship or PR is currently being reviewed and could increase in the future.

# The Accommodation Requirement (1)

## The Most Challenging Step

D7 and D8 applicants must have a 12-month rental agreement or property purchase agreement in place before their initial visa appointment in their home country.

It usually involves a significant financial commitment before approval, and not everyone is able to visit Portugal to view properties in person or spend time in their new home while waiting for their visa to be processed. Understandably, this makes many people hesitant to apply.

## Finding Comfort in your First Year

It's easy to feel pressure about where to live before you even arrive, but your first place doesn't need to be your forever home. I encourage clients to view their first year as a soft landing – a time to settle in, explore, and discover which part of Portugal truly feels right.

**Public schools** in Portugal are free and provide language support, making them a genuine choice for families keen on cultural and linguistic integration.

**Private Portuguese schools** follow the same curriculum as public schools but tend to have smaller class sizes, more resources, and a greater emphasis on extracurricular activities. Tuition fees vary but are generally lower than those of international schools, making them an attractive middle-ground option.

**International schools** cater specifically to the expat community. They follow internationally recognised curricula, helping ensure a smoother academic transition. There's over 50 international schools across Portugal, with the largest concentrations in Lisbon, the Algarve, and Porto.



# Shipping Your Belongings

Once your visa is approved, the next step is arranging the shipment of your belongings to Portugal. A variety of international moving and shipping companies operate globally, offering services by sea, air, or land, depending on your timeline, budget, and volume of belongings.

To avoid paying customs duties, it is strongly recommended to apply for a baggage certificate. This document allows for duty-free importation of household items, subject to certain criteria.

Be aware that securing duty-free status involves a few administrative formalities and documentation requirements. As part of our relocation support, we can guide you through this process to ensure your shipment meets all customs regulations and arrives smoothly at your new home.



# Bringing Pets



Yes, that's my dog – and no, it's not photoshopped. Gracefully mid-air!

Once your visa is secured, you can start planning to bring your pet(s) to Portugal. The country welcomes dogs, cats, and ferrets, and the process is fairly straightforward as long as you follow the timing requirements carefully.

Your pet will need to be microchipped with an ISO-compliant microchip and vaccinated against rabies. The rabies vaccination must be administered at least three weeks before departure and it must remain valid (within one year). You'll also need an animal health certificate issued by a registered vet within 10 days of travel.

You must also notify the Traveler's Entry Point at least 48 hours before arrival. You can bring up to five pets, each of which must be at least 15 weeks old.

# Cultural Differences

---



One of the first things newcomers notice about life in Portugal is the sense of safety. It's common to see people of all ages walking alone at night, even in larger cities. This calm, secure atmosphere is one of Portugal's most appreciated qualities.

The Portuguese are known for their warmth and friendliness. Greetings are often affectionate – a kiss on each cheek (*beijos*) or a warm handshake – and personal connections are highly valued in both social and professional settings.

Daily life here follows a slower, more relaxed rhythm. Punctuality is flexible, and social events often start later than planned. Embracing this unhurried pace helps newcomers settle into the Portuguese way of life.

The Portuguese take great pride in their local traditions and festivals. Each town celebrates its patron saint with lively music, dancing, and street food. These community gatherings are a true expression of Portugal's warm, festive spirit.

# Cultural Differences (2)



Meal times are also different in Portugal. Lunch (Almoço) is the main meal of the day and often lasts longer than visitors expect, especially on weekends. Dinner tends to be later in the evening, with restaurants rarely busy before 8 p.m.

You'll also notice how personal service and politeness are valued. Saying bom dia (good morning) or obrigado (thank you) goes a long way – it's part of everyday courtesy and something locals deeply appreciate.

While English is increasingly spoken, especially in the more touristy areas, taking the time to learn a few basic Portuguese phrases is a thoughtful way to show appreciation and respect for the local culture.

# Cost of Living

---



**Groceries** in Portugal are notably affordable, with local markets and supermarkets offering fresh produce and household essentials at very reasonable prices. On average, grocery costs are estimated to be around 40% lower than in the United States and roughly 30% lower than in the United Kingdom. Portugal also ranks among the EU leaders in low consumption of processed and ultra-processed foods, reflecting a strong cultural emphasis on fresh, home-cooked meals and locally sourced ingredients.

**Utilities**, including gas, electricity, water, and internet, are also reasonable – on average, 36% cheaper than in the US and 138% cheaper than in the UK.

**Dining out** in Portugal is remarkably affordable. A typical meal at a neighbourhood restaurant, complete with a jug of wine, often costs less than €10. At mid-range restaurants in Lisbon, meals generally range from €15 to €25 per person.



# Cost of Living (2)



**Housing costs** can vary, with prices in Lisbon and the Algarve having risen in recent years, particularly for properties in hotspot areas. In smaller towns and rural areas, rents and property prices remain significantly lower, often available for less than half the cost of properties in the country's main cities and coastal regions.

**Other everyday expenses**, such as healthcare, childcare, and leisure activities, are generally very affordable. Private health insurance, for example, can be obtained for a fraction of the cost compared with the US and the UK.

Overall, Portugal continues to offer excellent value for money, combining a high quality of life, vibrant culture, and stunning scenery with relatively low day-to-day expenses, making it an attractive destination for families, professionals, remote workers, and retirees alike.

# Tax

---



Understanding your tax obligations after moving to Portugal is essential. This overview is provided for general informational purposes only and is not financial or tax advice; professional guidance should always be sought to ensure compliance and to optimise your situation

Generally, you become a tax resident if you spend more than 183 days in Portugal within a given year – a threshold you will meet if you follow the stay requirements for renewing your residency permit. As a tax resident, you are liable for Portuguese taxation on your worldwide income.

Portugal has double taxation agreements (DTAs) with most countries, designed to prevent the same income from being taxed twice. While the situation for US citizens is unique, as the US taxes its citizens regardless of where they reside, various exemptions and mechanisms apply to help mitigate double taxation. For example, tax credits typically go toward reducing your US tax bill if it exceeds the amount owed in Portugal, helping to ensure you are not taxed twice on the same income

# Tax (2)



An important consideration is whether you may qualify for Portugal's Incentive for Scientific Research and Innovation (IFICI), also known as the NHR 2.0, a revamped tax regime designed to attract highly skilled professionals. Eligible individuals may benefit from favourable tax treatment on certain Portuguese-sourced income, including a flat 20% personal income tax rate for qualifying employment or self-employment earnings. In addition, certain foreign-sourced income, such as dividends, interest, and royalties, may be exempt from Portuguese taxation. While the new NHR regime is more targeted than its predecessor, it remains an attractive option for many newcomers seeking meaningful tax reductions.

Seeking professional advice from a qualified accountant is strongly recommended. We work closely with a trusted Portuguese accountant, whom we highly recommend for their expertise in managing international tax matters and ensuring compliance.



# Climate

---



Although Portugal's coastline lies along the Atlantic Ocean, its climate is more similar to that of Mediterranean countries, with hot summers and mild winters, making it appealing to those seeking pleasant weather year-round.

Portugal is a relatively small country, so regional climate variations are generally moderate. The northern regions, such as Braga and Porto, tend to be slightly cooler and wetter, while central areas, including Lisbon, enjoy warmer, drier conditions. In contrast, the Algarve boasts more sunshine, higher average temperatures, and less rainfall, making it particularly popular for those who prioritise sun and warmth.

Overall, Portugal has a temperate climate, rarely experiencing extreme heat or cold. Occasional summer heatwaves can bring high temperatures, but they are typically short-lived and do not last long.

# Is a Car Necessary?

---



This largely depends on your lifestyle and where you choose to live. For example, if you live in Lisbon or Porto, you'll likely need a car less than if you were to settle in a town on the Douro river.

Using Lisbon as an example, its extensive public transport system includes buses, trams, the metro, trains, and even ferries to cross the river. It's easy to use, inexpensive, and often more practical than driving. In fact, owning a car in Lisbon could even be discouraged due to the difficulty of finding parking and the significant traffic.

In the Algarve, there is a railway line covering the 139 km between Vila Real de Santo António and Lagos. However, while the journey takes under 90 minutes by car, it takes over 3 hours by train. Additionally, the train doesn't extend to all major towns in the Algarve, such as Tavira. Accordingly, living in the Algarve may present a stronger case for owning a car than living in areas within the Greater Lisbon district, for example.

# Residency Renewal & Stay Requirements



## D7 & D8 Visas

Once you convert your initial four-month visa into a residence permit, it will be valid for two years. After that, it can be renewed for successive three-year periods.

Regarding minimum stay requirements, you must spend at least 16 months in Portugal during the first 24-month period to qualify for renewal, and at least 28 months during each subsequent 36-month period. Failure to meet these residency requirements will make you ineligible to renew your permit.

## Golden Visa

For the Golden Visa, the initial residence permit is valid for two years and may be renewed every two years thereafter. The stay requirement is minimal – only 14 days of physical presence in Portugal during each two-year period.
